This letter will provide the quarterly report for the second quarter of FY 2015, relative to Host Community Premium Surcharge (HCPS) fees. This report will cover the period from January 1, 2015 through March 31, 2015.

Note: Units are Tons for all except residential accounts. For residential accounts, the units are the number of residential accounts billed that month.

GSWA billed \$78,039.84 in HCPS fees during the quarter ending March 31, 2015. Under Guam Law customers of GSWA are allowed sixty days to pay their solid waste bill. As a result, most of the fee billed in the quarter ending March 31, 2015 will not be collected until the next reporting period. The following table outlines the fees assessed since October 1, 2014, the fees actually collected and the funds available for transfer from the period ending March 31, 2015:

The total transfer to the Host Communities for this reporting period will be \$54,268.83 in equal amounts of \$ 27,134.42. The cash actually collected during this quarter is somewhat lower than in the past due to the timing of payments from some large commercial and government customers. We do not expect this to affect the total amount that will be collected in total for FY 2015.
