Dear Members of the Public Utilities Commission:

This letter will provide the quarterly report for the third quarter of FY 2017, relative to Host Community Premium Surcharge (HCPS) fees. This report will cover the period from April 1, 2017 through June 30, 2017.

Since the inception of these fees, their administration and payment to the beneficiaries has been complicated by the need to carefully monitor when these fees were actually paid. We believed this necessary since there is a significant delay between when the billing occurs and when payment is received by GSWA. Given the cash flow issues confronting GSWA early in our tenure, we determined the more complex analysis was needed to assure that GSWA's finances are were not negatively impacted by paying out the fees. With almost five years of data now available, we have decided to simplify this process. Beginning with this report, and on future quarterly reports, we will begin paying the total amount of fees assessed during the preceding quarter. While this does place the risk of non-collection on GSWA, we believe it is a small risk and that it can be better addressed in the future as a part of GSWA's monitoring of overall delinquency rates. To make this change it will require that we accelerate this year's payments with a one-time adjustment. This will increase the amount paid this quarter but will not change the total amount paid for the year.

During the quarter ending June 30, 2017, GSWA billed \$84,767.80 in HCPS fees. The following table outlines the commercial and government tonnage on which fees have been assessed during the period April 1, 2017 through June 30, 2017. The table also shows the total fees assessed on this tonnage. In addition, the table shows the number of residential customers during the period and the total fees assessed on these residential customers during each month of the period.
